Joseph C. A. Agbakoba is Professor of Philosophy at the University of Nigeria, Nsukka. He has been a visiting professor and scholar at the Goethe University Frankfurt and the University of Cape Coast. He is a former president of the Nigerian Philosophical Association; a member of the Steering Committee of FISP (International Federation of Philosophical Societies), and a Regional Coordinator for Africa for the Council for Research in Values and Philosophy (Washington, DC). His latest book is Development and Modernity in Africa: An Intercultural Philosophical Perspective (forthcoming 2019).

James Gerrie is an Associate Professor of Philosophy and Religious Studies at Cape Breton University in Nova Scotia, Canada. His research specialization focuses on the philosophy of technology and the philosophy of religion. His current research incorporates the questions: 'What is the proper relationship between technology, ethics and public policy?' and 'What is the proper role of religion in the modern age and the public sphere?'

David Lea is a Professor of Politics at the University of Papua New Guinea. His principal field is applied philosophy with central interests in the philosophical foundations of property rights and business ethics. He has published in the *Business Ethics Quarterly*, the Journal of Applied Philosophy, Business Ethics: A European Review, the Pacific Economic Bulletin, and Middle East Policy among others. His most recent book is Property Rights, Indigenous People and the Developing World: Issues from Aboriginal Entitlement to Intellectual Ownership Rights (2008).

Stephen Muzamhindo is a Regional Policy Analyst at Natural Resources Canada, Edmonton, Alberta, Canada. He holds a masters degree in public ethics from Saint Paul University in Ottawa, Canada.

Jānis (John) Tālivaldis Ozoliņš is a Professor of Philosophy at the College of Philosophy and Theology, University of Notre Dame Australia; in the Faculty of History and Philosophy, University of Latvia; and in the Department of Philosophy, Catholic Theological College, University of Divinity, Melbourne, Australia.

Pablo Iturrieta holds a doctorate in political philosophy (2017), an MA in philosophical psychology (2009), and BA degrees in theology (2006). His research interests are in political philosophy, applied ethics, metaphysics, and the philosophy of the human person. He is the author of *The Meaning of Religious Freedom in the Public Square* (forthcoming 2020).

David Klassen holds degrees in law and philosophy, including a PhD in Philosophy from the Catholic University of America. He is a lecturer at Corpus Christi College, University of British Columbia. He teaches philosophical anthropology and writes on humanism within western cultural traditions.

Jing-Jong Luh is Professor of Philosophy in the Graduate Institute of Philosophy and Director of Research Centre for Hermeneutics and Intercultural Philosophy at the National Central University, Taiwan. He received his doctorate in philosophy from the Universität zu Köln and specialises in German philosophy, hermeneutics, religious philosophy, intercultural philosophy, and contemporary interpretations of Chinese philosophy.

Gong Qun is a Professor in the School of Philosophy at Renmin University of China, Beijing. He is the author of more than 15 books, most recently *Traditional Values and Virtues in Contemporary Social Life* (2018), and is a major commentator on the writings of Alasdair MacIntyre and Martha Nussbaum, and has translated some of their works into Chinese.

Walter Schultz is Past-President of the Canadian Jacques Maritain Association and a former Editor of the journal *Etudes maritainiennes/Maritain Studies*. An adjunct professor at the Dominican University College, Ottawa, Canada, for many years he taught and worked in Program Design for the Dufferin-Peel Roman Catholic Separate School Board, Mississauga, Ontario.

William Sweet is Professor of Philosophy at St Francis Xavier University in Antigonish, Nova Scotia, Canada, and is President of the World Union of Catholic Philosophical Societies and of the Istituto Internazionale Jacques Maritain (Rome). The author or editor of over 30 books, primarily on human rights, the philosophy of religion, and the history of modern political thought, among his recent books are *Intercultural Dialogue and Human Rights* (2011, with Luigi Bonanate, Roberto Papini), *Cultural Clash and Religion* (2015), and *What is Intercultural Philosophy?* (2014). He is a Fellow of the Royal Society of Canada.
